IF CUSTOMER DOES NOT AGREE TO THESE TERMS, PLEASE PRESS THE "I DO NOT AGREE" OPTION AND DO NOT DOWNLOAD, INSTALL, ACCESS OR OTHERWISE USE THE APP.

Not limiting the foregoing, except as expressly provided in this EULA, this EULA does not grant Customer any rights to (and Customer will not): (i) grant any sublicense, distribute or transmit the App in whole or in part; (ii) modify the App; (iii) reverse engineer, decompile, or disassemble the App, except as expressly permitted by applicable law; (iv) use any trademarks of Licensor; (v) use the App for purposes other than Customer's personal use in accordance with this EULA. Customer's rights under this EULA may not be transferred, leased, assigned, or sublicensed. Any purported attempt to transfer, lease, assign, or sublicense of Customer's rights will be void.
4. **COPYRIGHT AND TRADEMARKS; NOTICES.** All right, title and interest in and to the App, including but not limited to trademarks and copyrights in and pertaining to the App, the accompanying printed materials, and any copies of the App, are owned or licensed by Licensor. The App is protected by copyright and trademark laws and may be protected by international treaty provisions. Customer will not move, modify or alter any Licensor copyright or trademark notice from any part of the App, including but not limited to any such notices contained in the physical and/or electronic media or documentation, in any of the runtime resources and/or in any web-presence or web-enable notices, code or other embodiments originally contained in or otherwise created by the App.
5. **DISCLAIMER OF WARRANTIES: LICENSOR HEREBY EXPRESS DISCLAIMS, ALL WARRANTIES EXPRESS, IMPLIED, OR STATUTORY, BY OPERATION OF LAW OR OTHERWISE, REGARDING THE APP, THE INFORMATION CONTAINED WITHIN THE APP, THE PRODUCTS AND SERVICES FURNISHED HEREUNDER OR IN CONNECTION HEREWITH, INCLUDING, WITHOUT**

LIMITATION THE IMPLIED WARRANTIES OF TITLE, NONINFRINGEMENT, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. WITHOUT LIMITING THE FOREGOING, LICENSOR DOES NOT WARRANT THAT THE APP WILL MEET CUSTOMER'S NEEDS OR EXPECTATIONS OR THAT USE OF THE APP WILL BE ERROR FREE OR UNINTERRUPTED.

6. LIMITATION OF LIABILITY: IN NO EVENT WILL LICENSOR OR ITS EMPLOYEES, OFFICERS, AGENTS, CONTRACTORS, LICENSORS OR CUSTOMERS ("LICENSOR PARTIES") BE LIABLE FOR DAMAGES OF ANY KIND WHETHER IN CONTRACT OR IN TORT, ARISING FROM THE APP OR ANY OTHER PRODUCTS AND SERVICES PROVIDED BY LICENSOR. IN NO EVENT WILL THE LICENSOR PARTIES BE LIABLE FOR ANY CLAIM OR LOSS INCURRED BY CUSTOMER, INCLUDING WITHOUT LIMITATION INCIDENTAL, SPECIAL, THIRD PARTY INDIRECT OR CONSEQUENTIAL DAMAGES OR FOR THE LOSS OF PROFIT, REVENUE, SOFTWARE OR DATA EVEN IF THE PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH POTENTIAL LOSS OR DAMAGE. 8. ASSIGNMENT: This EULA is not assignable without the prior written consent of Licensor.
9. EXPORT: Customer will not transfer to parties that will subsequently re-export Apps to embargoed countries or permit export, directly or indirectly, of any product acquired under this Agreement without first obtaining an export license from the US Department of Commerce or any other agency or department of the United States Government, as required.
10. CHOICE OF LAW: The Customer agrees that this EULA shall be governed by the laws of the State of Minnesota. Any disputes arising out of this Agreement will be brought in a court with jurisdiction in the City of Minneapolis, County of Hennepin, Minnesota.
11. MISCELLANEOUS. This EULA, the Terms of Use and the Privacy Policy contain the complete and exclusive agreements between Customer and Licensor with respect to the App and may be amended or modified only in a written instrument signed by a duly authorized representative of both parties. If any part of this EULA is found invalid, such invalidity will not affect the validity of remaining portions of this EULA, and the parties will promptly substitute for the invalid provision a provision that most closely approximates the intent and economic effect of the invalid provision. Failure by a party to complain of any act or failure to act of the other party or to declare the other party in default, irrespective of the duration of such default, will not constitute a waiver of rights hereunder.
